Fireworks: We would appreciate getting receipts with some more time. Make sure that the board is clear when asking for things that can be unclear to those providing documentation. Please try to be professional when responding to requests. Make sure that the information is clear for Boosters in the future. Renay would like the information so her Cheer Boosters can be clear about what and why things are being asked for. This will make it easier for future board members at all levels.

Melinda would like to meet after the meeting so Fireworks booth representatives can be on the same page.

Renay is asking for financials for the past two years from the last years. She is requesting statements for the past two years. She would like a full treasurer's report for the past two years.

Mistala relayed that we are all new and trying to figure things out. We are also flying blind, and we would appreciate information to help us out.

Mistala said that she is not doing the position again because of the "politicalness and gossip" of the board. She mentioned that she is not on campus, and this place is toxic, and feels sad. Mistala said that "she is here for the kids" and that it is hard when people are negative. On record: She is bothered by the negativity and that we as a board, apologize for anyone who was rude to Renay or whoever she was representing.

Renay: She has tried to help but was given a rude reply. She wants to help.

Rhonda: Does each organization have a cap on rollover for the money that can be moved to next year?

Melinda: We would like coaches to have a list of the money in their account and an idea of how it will be spent.

Rhonda: Can there be a cap on the rollover?

JP: Track has both ASB and Booster funds. ASB funds are used for Chino Relays. Pole Vault pit covers were used from the ASB funds, but Chino Relays has not been profitable in all years. Every year is different.

Rhonda: There is a budget for next year. She would like a budget for the next year.

Melinda: Because of inconsistency.

Rhonda: There needs to be a budget so parents know where the money is going.

Hinkle: The money going through ASB needs to have a budget.

Melinda: We would like to know where the money is budgeted for.

Hinkle: Summer Camp coaches are given a list of requirements. Part of this is a budget for summer camps.

Angulo: Wrestling has to account for possible expenses. For example, Making it to state for hotel rooms.

Mistala: Where is the money going to?

Angulo: You can't predict where the money is going. Kids can get hurt, and there is no fundraising time for CIF/playoffs/etc...

Rhonda: What is the time for rollover?

Melinda: This is why we ask for fundraising in ASAP. This will help with budgets.

Rhonda: Said that she thinks it is weird that there is no budget.

Ochoa: There are coaches who have been here a dozen years. Please reach out to them if you have any questions. They know what is needed from the parent/team perspective. Mr. Hinkle is also a good resource to go to.

Hinkle: A budget can be made.

Larned: It would be helpful to parents for a budget to be public.

Angulo: Waiting for quotes from rings. They may need some support for kids who need help.

Hinkle: Boosters did pay for softball rings when they won CIF in the past.

Rhonda:

Data Base Google Sheet could be used. To keep track of scholarship contacts, etc... This way new groups can be easily able to take up the volunteer.
